## "COOKIES" (COOKIES)

When you visit the website, a cookie will be saved on your computer. A cookie is a small text file that helps web analytics services identify you as a visitor. The web analytics service collects data about your use of the site with your permission (number of open apartments, time of visit, which operating system you use, the country you are in...).
